# Lee County Fair Queen and Jr. Queen Competition Rules & Regulations

1. Each contestant for the Senior Queen must be 16 years of age and not more than 21 years of age on August 13, the first day of the 2020 Iowa State Fair.
2. The Junior Queen contestants must be at least 11 years old and not more than 15 years of age on July 1, 2020. Junior Fair Queen does not go on to the State Fair.
3. Each contestant must reside in Lee County, IA or an adjoining county if the majority of her activities are in the county she represents.
4. Contestants must never have been married, have children, or been convicted of a felony.
5. Each contestant must be an active member of at least one service organization in her community such as, but not limited to a church group, Girl Scouts, 4-H, FFA, etc.
6. No professional model (one who has ongoing employment in which modeling was the primary part of the job) is eligible to compete.
7. **All contestants are expected to conduct themselves in a manner that reflects positively on themselves, their family and the Lee County Fair. This also includes how you conduct yourself on social media.** Should any candidate become involved in any activity that reflects negatively on themselves, their family or the Lee County Fair, they may be required to forfeit their crown, title, and scholarship.
8. The Lee County Fair Queen will be **EXPECTED** to represent Lee County at the Iowa State Fair Queen Pageant August 11<sup>th</sup>-15<sup>th</sup> (tentative), 2020, providing their own transportation to and from Des Moines. The Fair Board will pay entry fee to participate at the Iowa State Fair, and provide a monetary stipend to help cover cost of attire for competition. **As well as**, attend local events, i.e. West Point Sweet Corn Parade, Ft. Madison Rodeo Parade, and Donnellson 4<sup>th</sup> of July Parade.
9. **ALL CONTESTANTS are REQUIRED** to participate throughout the fair in activities such as ribbon presenting, Kid's Day, ticket sellers & takers, etc. You will be required to check in with the queen committee or at the learning center before you work.
10. Contestants will be judged on:
  - appearance, attitude, awareness, charm, citizenship
  - contribution to the community, leadership & poise
  - previous Lee County Fair involvement is considered during judging
11. ALL contestants are to be respectful at all times to all fair board members, other contestants and all patrons involved with the Lee County Fair. If an issue occurs, please go to the queen committee chair immediately.
12. Each Queen and Junior Queen contestant is required to get her own sponsor or sponsors. There is a \$100 entry fee.
